On August 12, 2019, at approximately 8:58 a.m., the Federal Bureau of Investigation (FBI) executed a search pursuant to a warrant signed and authorized by the Honorable [REDACTED] United States District Court for the District of Virgin Islands, at a premises known as Little Saint James, United States Virgin Islands.

At the time of the FBI's arrival to Little Saint James, Attorney [REDACTED] was present with an assistant and informed New York FBI's Assistant Special Agent in Charge [REDACTED] that he heard from "your attorneys" last night about the search. Also present on the island were two armed security personnel. The four individuals departed the island for the duration of the search.
